**How to pay your taxes:** we have a drop box located on the ramp at the town hall to deposit your payment, mail USPS, or pay online via the town website. Online payments are also available on the [barroncountywi.gov](http://barroncountywi.gov) website, by using the quick link “pay online” on the right side of the page. Select “Town of Sumner”, enter in the parcel number, use “add item” to enter multiple parcels. A fee will be applied to your total if you use electronic payments. **Receipts will only be issued if a self-addressed stamped envelope is provided with your tax payment.** You may print proof of payment at [www.co.barron.wi.us/GCSWebPortal/Search.aspx](http://www.co.barron.wi.us/GCSWebPortal/Search.aspx). This receipt is available after payments clear. Please allow a minimum of 7-10 business days for processing. If two full weeks have passed and your check has not cleared, feel free to contact me to confirm receipt of your payment. Over payments less than or equal to \$5.00 will not be refunded.

**SEVERE WEATHER ALERTS:** There is a free app “CODE RED MOBILE ALERT” featuring customized messages for a variety of emergencies, available for cell phone users. Go to [barronsheriff.org](http://barronsheriff.org) to sign up.

**ATV TRAILS:** Our town roads are now open to ATV traffic. Help us protect our ATV rights by reporting misuse of trails and routes. This may be done anonymously unless there is a trespassing complaint. Contact the Barron County Sheriff non-emergency line at 715-537-3106, offenders will be cited and pay for damages.

**DO NOT PLOW SNOW FROM YOUR DRIVEWAY ACROSS THE TOWN ROAD.** Wisconsin Statute 346.94 (5), (7), applies to miscellaneous prohibited act of Placing Injurious Substance on a roadway. The section reads, “No person shall place or cause to be placed upon a roadway any foreign substance which is or may be injurious to any vehicle or part thereof.” Do not push snow from driveways onto or across county, state, or town roadways, it is dangerous for motorists and the ridges left behind damage the town’s equipment. **A significant fine will be issued for each individual offense.** Considerable time and expense go into keeping our roadsides looking neat. Please do not throw debris into the road right away (33 feet from center of the road). Rocks, chunks of cement, trash, brush, etc. damage the mowers and it is very costly to replace mower blades. **Landscaping and ornamental plants MUST be kept out of the right of way. If they are within the 33 feet from center of the road, they will be mowed.** There is a small pile of salt-sand located on the west side of the town shop for your use to pick up.
