<u>Proposed change to intersection of 16th Ave and 27th Street from a 2-way stop to a 4-way stop.</u> Patrolman Svoma's stated the intersection is dangerous for large equipment. Board needs more research before a decision is made.

<u>Purchase or adjust services from Cintas for uniforms, rugs, supplies, or purchase uniforms rugs etc.</u> Svoma said we can buy uniforms outright, board wants prices before decision.
