Bids will be publicly opened at the Town Board meeting that starts at 7:00 p.m. May 13, 2025 at the Sumner Town Hall, 1550 24 ½ St, (Barron Co Hwy M) Rice Lake, WI. This is LRIP TRI project #18805. Bids will be awarded at a later date pending DOT approval.

PROJECT LOCATION: 27th St North, Beginning at 17th Ave intersection / Bridge. Paving shall be 20' over the bridge to the first farm field driveway on the right or east side of the road, narrowed down to 18' wide to just past the first residence driveway on the right, about 1580' from the 17th Ave intersection, ending just past the last driveway on the left or West, totaling about 2500' of road surface to be paved.

PROJECT DESCRIPTION

- Shape & compact the gravel base with a normal 2-percent centerline crown.
- Additional gravel if needed will be provided by the Town of Sumner.
- Furnish and install DOT 4 PG- MT 58-28 S Hot or Warm mix Asphaltic Pavement.
- The pavement shall start at a minimum of 20 feet wide over the bridge, narrowing down to 18' of a 2 ½ inch compacted thickness with a 2% slope crown.
- Include paving, residential driveway easements.
- The finish shouldering shall be included in this bid.
- The work schedule will be mutually agreed to by the Town of Sumner and the successful bidder.
